**Opening Remarks**

Mr. Homady teaches golf clinics as well as private lessons, and will custom-fit clubs to your needs.

At the conclusion of Mr. Homady's presentation, Kathy introduced Meghan Stahl-Skinner of Alleghenies United Cerebral Palsy.
